
The national picture on council finances



- Spending on neighbourhood services in the most deprived fifth of LAs fell especially sharply in:-
- ☐ Financial support to bus operators
- ☐ Food and water safety
- □ Road safety and school crossings, community centres and halls,
- ☐ Crime safety and CCTV.

Percentage change in TSE by neighbourhood service sub-group and level of deprivation, 2010-11 to 2015-16





Neighbourhood services where TSE fell by at least 20%



Reduction 2010/11 to 2015/16	All local authorities	Most deprived fifth of local authorities
At least 60%		Support to bus operators; community development
At least 50%	Support to rail operators	Tourism; crime, safety and CCTV
At least 40%	Community development; tourism	Environmental initiatives; congestion, bus lanes, traffic; economic and business development

Charging powers



- Goods and Services Act 1970
- S 93 LGA 2003 Broad powers to charge
- Localism Act reaffirms charging powers and
- Section 45 Environmental Protection Act 1990 (commercial waste)
- Civic Restaurants Act 1947
- Section 32 Local Government (Miscellaneous Provisions) Act 1976

But....



- Distinction on statutory duty to do something
- Ability to raise fees and charges
- Political buy-in?
- The landscape is changing..

Food Inspections?

Food standards agency advice March 2017

Following the trial of charging for requested FHRS reinspections/re-visits with some local authorities in England, using existing powers in the Localism Act (2011) (see ENF/E/16/053 dated 12th September 2016) FSA can now confirm a change in policy allowing use of these powers by local authorities in England2 to introduce cost recovery for requested FHRS re-inspections / re-visits

NB Food premise registrations etc. remain free

Pest control?



Enforcement powers but doesn't prevent charging.....

- The Prevention of Damage by Pests Act 1949 section 4 which requires owners and occupiers to take action to control rats and mice on their property
- Public Health Act 1936 Section 83 (as amended), deals with verminous premises. – e.g. infestations of cockroaches, bedbugs etc.
- Environmental Protection Act 1990 gives further provision for dealing with pests, which may be prejudicial to health or a nuisance.
- Housing Act 2004 (Housing Health & Safety Rating System) gives provision for an improvement or prohibition notice to be served on landlords e.g. private sector housing, to rid the premises of pests

Example charges....



- Ants £55 (per treatment inside the home)
- Bed Bugs £92 (for a comprehensive course of treatments)
- Beetles £68 (per treatment)
 Birds contact us for a quote
 Cockroaches £80 (for a comprehensive course of treatments)
- Fleas £74 (per treatment)
- Mice £67 (includes three treatment visits)
- Rats £31 (includes three treatment visits, either inside or outside)
- Squirrels £133 (includes three treatment visits)
- Wasps £56 (per treatment)

Justifying charges?



- Residents available when the pest technician calls!
- Avoid wasted call-outs
- Value of avoiding re-infestation encourages landlords / residents to follow advice or face further charges
- But... risk of people not calling because they do not want to pay!

Charging ahead



General power of competence?



- General Power of Competence
- Charging not for a commercial purpose
- Defined as 'subject to a duty to secure that, taking one financial year with another, the income from charges (allowed) does not exceed the costs of provision'
- Simplistic but effective mechanism

Preparing to charge



- ✓ Review existing fees and charges
- ✓ Take cognisance of current council policy but...
 gain buy-in from transformation or
 commercialisation leads
- ✓ Do not overstate the market available to you
- ✓ Areas like pest control can be competitive
- ✓ Capacity balance of risk on new employees or 'mopping up ' current productivity

Practical steps



- Pricing strategy
- Sales platform marketing the service
- Invoicing and payments (VAT)
- Business development strategy can you link marketing of pest control to your registration and inspections?
