Inspections and Interventions



5.5 Number of inspections/audits per food hygiene category

For each Category of premises, show the total number of **inspections/audits** (and partial inspections/audits) which the authority carried out during the year.

Interventions refers to the full set of official controls. A further distinction is that a risk rating is carried out only after an inspection/audit but would not be carried out after any other type of intervention. A distinction is made in this template between interventions requiring greater inputs such as inspections and audits compared with other types of interventions. Consequently data is collected separately for inspections/audit and interventions. One covering inspections/audits and the second refers to 'other interventions'.

Count all inspections and audits (i.e. if a premises was inspected or audited four times then count as four).

Do not count reinspections within your inspection total - these should be recorded under 'Reinspection of Premises'

Interventions include the following official controls; monitoring, surveillance, verification and sampling (where the analysis is to be carried out by an official laboratory).

Interventions refers to the full set of official controls. A further distinction is that a risk rating is carried out only after an inspection/audit but would not be carried out after any other type of intervention. A distinction is made in this template between interventions requiring greater inputs such as inspections and audits compared with other types of interventions. Consequently data is collected separately for inspections/audit and interventions. One covering inspections/audits and the second refers to 'other interventions'.
